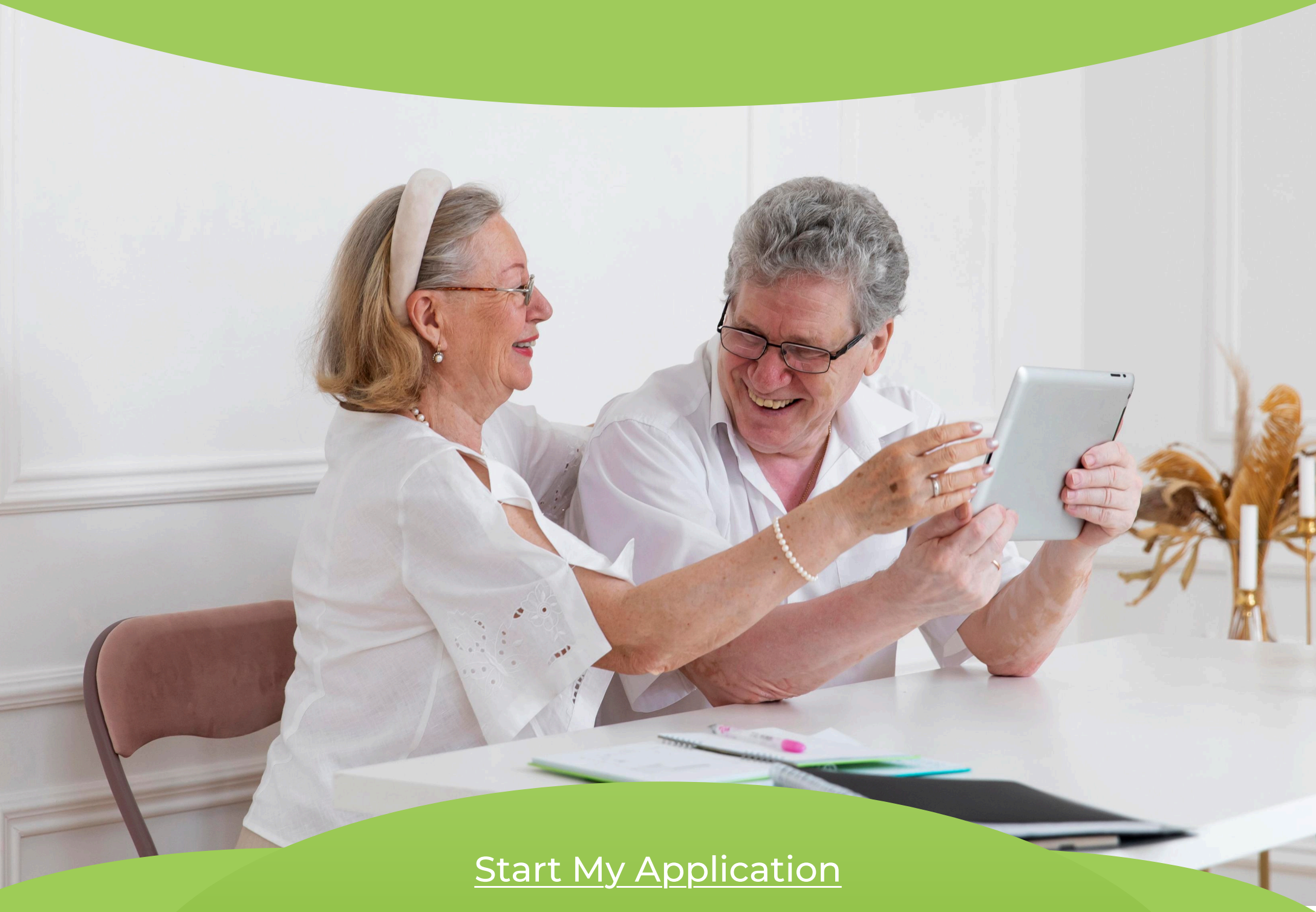

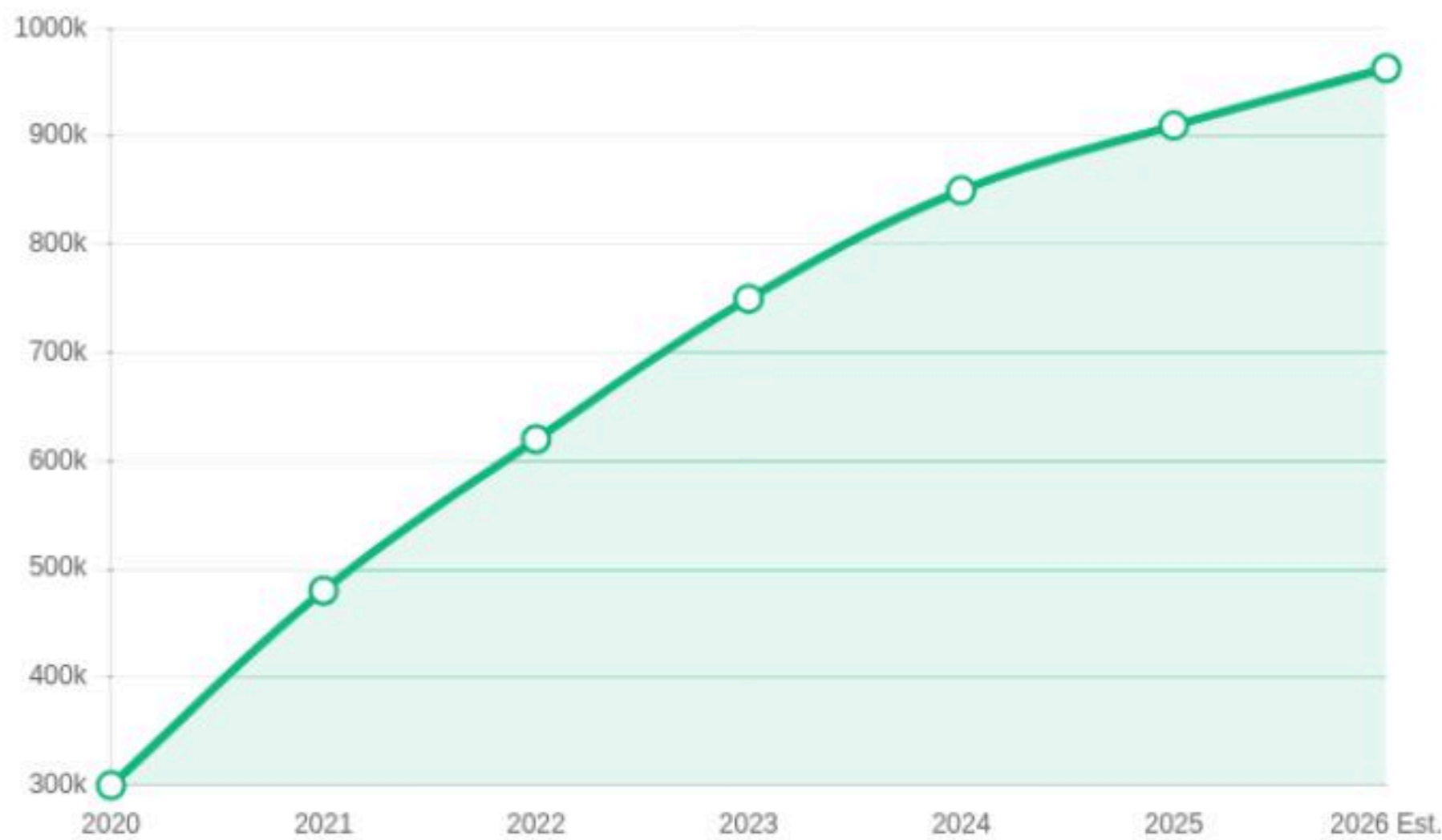

# The "Seasonal Resident" Hack

Don't wait for your DMV appointment. You can qualify for a card if you reside in Florida for at least 31 consecutive days per year. This is the fastest way for new movers to get legal.

- 1 Proof of Address:** Provide two documents such as a residential lease, utility bill (max 2 months old), or bank statement.
- 2 Identity:** Use your out-of-state Driver's License or Passport as your primary photo identification.

## Seasonal Resident Documents (Choose 2)



Deed, Mortgage, or Lease Agreement



Utility Hook-up or Work Order (within 60 days)



Utility Bill (not more than 2 months old)



Mail from financial institution or govt agency

# Your 5-Step Roadmap to Relief

From moving day to dispensary checkout.

1

## Clinic Consultation

Book your in-person evaluation with [MMJ Health](#). Bring out-of-state records or meds.

2

## State Registry Entry

Our doctor enters your approval into the state registry immediately after your visit.

3

## Online Application

Pay the \$75 state application fee via the MMUR portal and upload residency proofs.

4

## Email Approval

Wait 5-10 business days for the DOH email. This digital approval acts as your temporary card.

5

## First Purchase

Visit any dispensary with your digital approval and ID to shop immediately.

What are Floridians actually buying? Despite a massive variety of high-tech products, traditional smokable flower remains the top choice for patients.



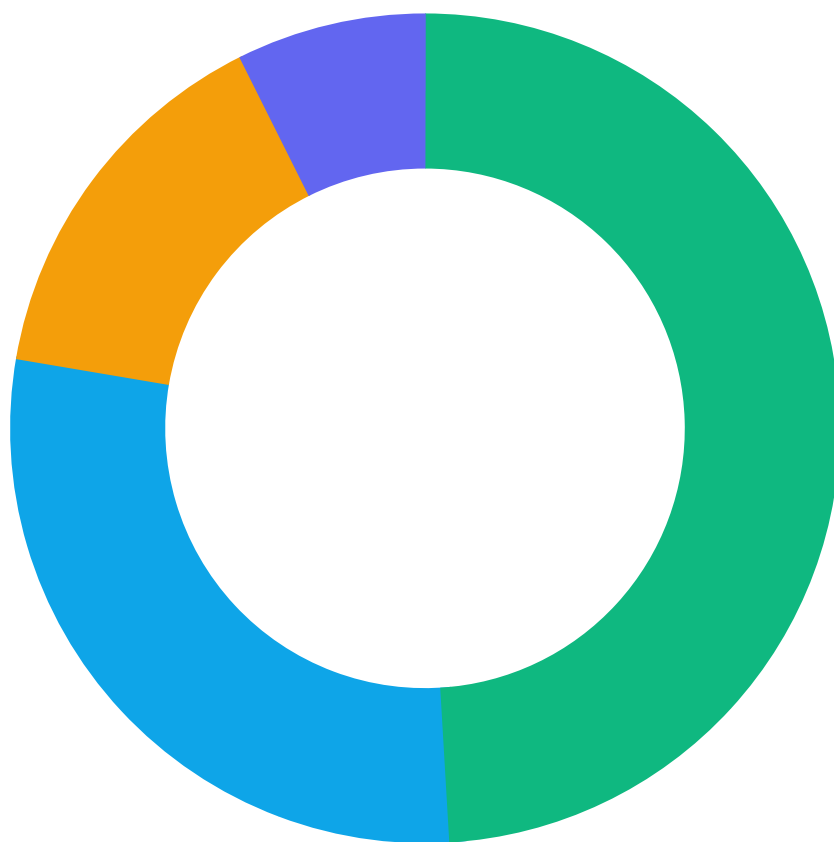
## Smokable Flower (48%)

## Travel (HB 1003)

Driving with an "open container" is a criminal offense. Always keep meds in original dispensary packaging with labels attached.



## Gun Rights

Recent 11th Circuit Court rulings have challenged federal bans on MMJ patient firearm ownership, but the landscape remains complex. Consult a legal expert.



## Workplace (SB 136)

Public employees have new protections, but private employers can still enforce drug-free policies. Review contracts before disclosing.
